ELECTION OF OFFICERS FOR MUNICIPAL AND DIVISION FEDERATED SUPREME SECONDARY LEARNER GOVERNMENT (SSLG) AND SUPREME ELEMENTARY LEARNER GOVERNMENT (SELG) FOR THE SCHOOL YEAR 2023-2024

To: Public Schools District Supervisors

Public and Private Elementary and Secondary Schoolheads

All Others Concerned

- 1. As provided in DepEd Order No. 47, series of 2014, otherwise known as the Constitution and By Laws of the Supreme Pupil Government and Supreme Student Government in Elementary and Secondary Schools, it is mandated to federate all SSG and SPG organizations to establish a representative body which will foster leadership and promote learners' development and welfare. Further, the OUOPS Memorandum No. 2023-03 from the Undersecretary of Operations dated May 5, 2023, titled Interim Guidelines of the Learner Government Program (LGP) for SY 2023-2024, provides the indicative dates for the school, division, regional, and national learner government elections.
- 2. Relative to this, the School Governance and Operations Division Youth Formation Section (SGOD-YFS) enjoins **all Public and Private Elementary and Secondary Schools** to conduct the school-based learner government elections on or before their respective scheduled Municipal Federation Elections. The newly elected school presidents shall attend the Election of Officers for Municipal and Division Federation of Supreme Secondary Learner Government (SSLG) and Supreme Elementary Learner Government (SELG) on the following dates and venue:
