ON-SITE MONITORING AND EVALUATION OF THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM AND OTHER OPLAN KALUSUGAN SA DEPED PROGRAMS

- 1. The School Health Section of the School Governance and Operations Division will conduct an on-site monitoring and evaluation of the implementation of the school-based feeding program (SBFP) and other *Oplan Kalusugan sa DepEd* programs this month of November 2023. The operation of the school canteen, school kitchen, and feeding area will also be monitored and evaluated.
- 2.
