ADDITIONAL INFORMATION TO DIVISION MEMORANDUM NO. 006, S. 2024 (CONDUCT OF SCHOOL-BASED MIDYEAR PERFORMANCE REVIEW AND EVALUATION AND IN-SERVICE TRAINING FOR TEACHERS)

To: Assistant Schools Division Superintendent Public Schools District Supervisors Public Elementary and Secondary Schoolheads

- 1. Relative to Division Memorandum No. 006, s. 2024 dated January 9, 2024, titled **Conduct of School-based Midyear Performance Review and Evaluation (MPRE) and In-Service Training (INSET) for Teachers**, all public elementary and secondary schoolheads are advised to take note of the following:
 - a. Per DepEd Memorandum DM-OUHROD-2024-0037 (Guidelines on the Conduct of the In-service Training for Teacher for School Year 2023-2024), the school-based INSET shall focus on the teachers' learning and development needs and on sharing information on the following policies and priority programs:
 - Training for Teachers Teaching Non-Major Subjects (e.g., Filipino, MAPEH, etc.);
 - Microsoft 365 Productivity Online Training through DepEd Philippines;
 - National Learning Camp;
 - National Reading Program;
 - National Mathematics Program;
 - Catch-up Fridays;
 - Early Language Literacy and Numeracy (ELLN);
 - Policy Guidelines on the Implementation of the Comprehensive Sexuality Education (DepEd Order No. 31, s. 2018);
 - Child Rights Policy: Adopting the Rights-Based Education Framework in Philippine Basic Education (DepEd Order No. 31, s. 2022);
 - DepEd Child Protection Policy (DepEd Order No. 40, s. 2012); and
 - Safe Spaces Act (Republic Act No. 11313).
 - b. The Maintenance and Other Operating Expenses (MOOE) can be utilized for the conduct of the school-based INSET in accordance with DepEd Order No. 13, s. 2016 (Implementing Guidelines on the Direct Release and Use of MOOE Allocation of Schools, Including Other Funds Managed by Schools), subject to the usual government accounting and auditing rules and regulations.
