CHANGES AND ADDITIONAL INFORMATION FOR THE CONDUCT
OF THE 2024 DIVISION SCHOOLS PRESS CONFERENCE

1. The Curriculum Implementation Division encourages all public and private schools to participate in this year's Division Schools Press Conference (DSPC) to be held on March 22-23, 2024, in Glan, Sarangani Province. Participating schools with entries for the different DSPC competitions or for observation purposes only must adhere to the no disruption of classes policy stipulated in DepEd Order (DO) 9, s. 2005 (Instituting Measures to Increase Engaged Time on Task and Ensuring Compliance Therewith) and to the policy on off-campus activities specified in DO 066, s. 2017.
2. All identified TWG members (see enclosure), District Journalism Coordinators, School Paper Officers, and School Paper Advisers/Delegation Head of each competing school shall attend the orientation on March 15, 2024, at 1:00 p.m. at Lun Padidu National High School, Malapatan, Sarangani Province. Moreover, all identified proctors from the previous memorandum, along with the DSPC Documentation Team, shall attend the orientation set for March 14, 2024, at 2:00 p.m. at Glan School of Arts and Trades.
3. Please take note of the following information:
 - a. Entries for the school paper competition shall be submitted in a PDF file **on or before March 20, 2024**. The link will be sent to Journalism Coordinators via Facebook Messenger.
 - b. On Day 0 (March 21, 2024), schools with a target arrival time of 4:00 p.m. or below must notify the Division Management and the host schools in advance. Proctors must also cater the entries for group competitions to check, validate, and keep the necessary gadgets for the activity.
 - c. Checking of gadgets shall be from Day 0 to 10:00 a.m. of Day 1 only.
4. All student-journalists and teacher-journalists are invited to be part of the special edition of the Sarang-ini Publication covering the conduct of the SPAA Meet for practice purposes. Interested writers and coaches may contact the Division Journalism Supervisors.

5. The endorsement of the list of participants per district (1 for DSPC competitors and 1 for observers) shall be prepared and signed by the District Journalism Coordinators and noted by the District Head. This should be submitted on or before March 18, 2024.
6. All expenses incurred by the participating schools during the DSPC shall be charged against local funds/school MOOE/SEF subject to the usual accounting and auditing rules and regulations.
