To maximize the participation of the regional qualifiers and to avoid disruption of classes, the schools with teacher-coaches and TWG members shall abide by the provisions under DepEd Order (DO) No. 9, s. 2005 – **Instituting Measures to Increase Engaged Time on Task and Ensuring Compliance Therewith** and DO 34, s. 2022 – **School Calendar and Activities for the School Year 2022-2023**.

4. All teaching, non-teaching personnel, and monitors who rendered services during weekends/holidays relative to the conduct of 2024 DSPC shall be entitled to compensatory time off and service credits, whichever is applicable.

5. Expenses of the participants related to the conduct of the DSPC/RSPC activities are chargeable against the school MOOE/Special Education Fund/School Campus Journalism Fund and other available local funds subject to the usual accounting and auditing rules and regulations. Moreover, the
