SCHOOLS AUGMENTATION FOR THE CONDUCT OF DEMONSTRATION TEACHING, TEACHER REFLECTION EXAMINATION, INTERVIEW OF TEACHER I AND TEACHER II APPLICANTS, AND OTHER SELECTION-RELATED ACTIVITIES IN MALAPATAN 1 AND MALAPATAN 2 DISTRICTS

1. In connection with Division Memorandum No. 037, s. 2024 titled **Call for Applications for Kindergarten, Junior High School, and Senior High School Teacher I Applicants for SY 2024-2025**, please be informed that the Malapatan 1 and Malapatan 2 District Offices will conduct the demonstration teaching, teacher reflection examination, and interview of Teacher I and Teacher II applicants on April 3-5, 2024.

2. These activities will be facilitated by the Division Selection Sub-Committee Chairperson and Members in the said districts on April 3, 2024 for the Teacher Reflection Examination, April 4-5, 2024 for the Demonstration Teaching, and April 8-12, 2024 for the Preparation and Finalization of CAR-RQA that includes the following:

- a. Evaluation and assigning of points of the ETE and LET based on the criteria;
- b. Consolidation of Demonstration Teaching results; and
- c. Checking of Teacher Reflection (TR) Written Examination.

3. As per item number 3 of Division Memorandum OSDS-2024-051, the Schools Division Office will provide augmentation per district office for the operating expenses to be incurred during the conduct of selection-related activities. The schools are also required to augment support to their respective district offices relative to the undertaking which shall be charged against local funds subject to the usual accounting and auditing rules and regulations.

4. An amount of Five Hundred Pesos (P500.00) will be charged to all school heads to defray expenses for the conduct of the said activities.
