2. The *Department of Education-Sarangani Division* now invites bids for the above Procurement Project. Bidders should have completed, within *three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders)*

3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

5. A complete set of Bidding Documents may be acquired by interested Bidders on July 25, 2023 to August 8, 2023; from the given address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (1,000.00)

6. The *Department of Education-Sarangani Division* will hold a Pre-Bid Conference¹ on **July 25, 2023; 9:00** A.M. thru virtual platform Microsoft Teams which is open to all interested prospective bidder. Please inquire at the given contact person and numbers below for the link and other concerns.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **August 8**, 2023; 9:00 A.M. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on August 8, 2023;9:01 A.M. thru blended platform face-to- face and online for Bids and Awards Committee, Technical Working Group Members and BAC Secretariat at *DepEd New Division Conference Room, Capitol Compound, Alabel, Sarangani Province* while virtual platform Microsoft Teams to all prospective bidders and bidders' representatives who choose to attend the activity

10. The *Department of Education-Sarangani Division* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
